OF CIVIL DISTRICT COURT**


**ON MOTION OF** Chelsey Richard Napoleon, Clerk of Civil District Court for the Parish of Orleans, State of Louisiana, appearing herein and on suggesting to the Court, due to the possible dangers associated with the weather advisory currently in place for the Parish of Orleans related to Tropical Storm Sally; as a result, the possible dangers of extreme weather conditions will create hazardous and unsafe conditions for employees working in the building at 421 Loyola Avenue, New Orleans, Louisiana, and 1340 Poydras Street, New Orleans and the general public conducting business with the Clerk's office on Monday, September 14, 2020 and Tuesday, September 15, 2020 and on further suggesting to the court that her office should be closed pursuant to La. R.S. 1:55 so that such closure will be considered a legal holiday so that prescription of all lawsuits being filed with her office will be interrupted on the aforesaid date and on further suggesting to the Court that written approval of the Chief Judge of the Civil District Court was given as required by the statute to authorize such a closure. The office shall re-open on Wednesday, September 16, 2020.

**IT IS ORDERED** that the Clerk of Civil District Court is authorized to close the Clerk of Civil District Court, Civil Division, Land Records Division, Mortgage Division, and Conveyance Division on Monday, September 14, 2020, and Tuesday, September 15, 2020. The office shall re-open on Wednesday, September 16, 2020. Said closure shall have the same force and effect as a legal holiday pursuant to La. R.S. 1:55; and the Clerk shall follow the advertising and statement requirements of said section.
